Sir/Madam,

This is with reference to school application on the subject cited above. I am directed to convey the approval of the Board for Affiliation i.e Upgradation to Senior Secondary Level as per details given below :

Sl. No.	The school is directed to ensure that :
1	The total number of sections of the school shall be restricted to 16, of which not more than 1/3rd sections may be used for senior secondary classes. In the rooms between 400-500 Sq.Ft, the enrollment to be restricted to 32 students per section. Any further increase of section shall require prior approval of the Board, subject to compliance with affiliation bye laws and availability of rooms of 500 sq. ft. dimension.
2	The composite science lab is seen as undersized and understocked with no work stations.No safety measures are seen like exhaust fans and fire extinguishers in composite lab and chemistry lab.All the labs have plastic chairs and curtains(fire hazards) which are in appropriate.The school shall upgrade all the science labs as per SoPs issued by the Board within 3 months and submit compliance with videography on SARAS.
3	Ramp at the entrance has not been covered in the videography. The school should make provision for CWSN students to access upper floors by a ramp or lift as prescribed by the RPwD Act 2016 and Circular No. 5 dated 06.03.2023 issued by the Board and submit the compliance through videography within 3 months on the SARAS portal.
4	The land area mentioned in the land certificate is 18817.88 Sq.Mtrs., whereas in the OASIS data filled by the school, it is mentioned that total land area is 16794 Sq.Mtrs.

	Hence, school is directed to apply on SARAS portal for correction of land on OASIS.
5	School has uploaded the water sample test report of District Water Testing Agency. School is directed to obtain safe drinking water and sanitary condition certificate, as per prescribed format and submit the compliance.
6	Math lab is seen as under sized and understocked, arranged temporarily. It has no work spaces for students, seating and storage. The school shall upgrade the math lab as per SoP issued by the Board within 3 months and submit compliance with videography on SARAS.
7	The school has created CWSN toilets on raised platforms and hence they are not accessible to CWSN. Inside the support rods are incorrectly placed. The school shall construct separate toilets for CWSN, boys and girls on every floor, with proper permanent signage indicating the floor number as per norms of RPwD Act and guidelines issued by the Board within 3 months and submit compliance with videography on SARAS.
8	The school shall ensure the training of its teachers with CoE Bhubaneswar within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be

The approval of the Board as mentioned above, is subject to the following conditions:-

1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye - Laws-2018.
2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school shall renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.
